The cost of bidding documents (Non-Refundable) Rs. ---/- may be deposited in shape of Demand Draft of any scheduled bank drawn in favour of ~~Regional Pay and Accounts Officer, MORT&H, payable at Chandigarh.~~ Rs. 2000/- for Secretary General, IRC New Delhi+ Rs. 18000/- shall be deposited through RTGS with SBI, Rupnagar A/C No. 34996004929, IFSC Code SBIN0006342 of Executive Engineer, Construction Division PWD B&R Br, Rupnagar
4. The bidders should have the necessary Portal enrolment with his/her own Digital Signature Certificate (DSC).

5. The bidders should keep checking the website for any addenda/corrigenda to the notice/bidding documents till the date of on-line submission of bids, and the bidder should incorporate the same in his bid documents.
6. Bids must be accompanied by bid security / EMD of the amount specified for the Project/Work/Works in the table above. Bid security / EMD can be in the shape of Bank Guarantee in favour of Executive Engineer , Construction Division, PWD B&R, Rupnagar . Security/EMD can also be furnished in the form of Deposit at Call or as specified in the bidding document, and shall have to be valid for 45 days beyond the validity of the bid.
7. The original DD for cost of bidding documents & Deposit at Call/ Bank Guarantee for earnest money or in the form as specified in the bidding document should be deposited with the concerned Executive Engineer before the opening of the technical bid as given in the table above and the scanned copies of the same should be attached in Technical Bid uploaded as prescribed in the Standard Bidding Document (SBD), failing which the bidder will be disqualified.
8. Bids must be submitted online through a e-portal www.eprocure.gov.in/eprocure/app before the time specified in the table above (as per server clock). The department does not take any responsibility for the delay caused due to non-availability of internet connection or network traffic jam etc. for online bids.
9. Bid documents consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor can be seen on website www.eprocure.gov.in/eprocure/app and scanned copies of the required documents and information as per section-2 (formats & annexure) should be attached in the technical bid as prescribed in the SBD.
10. Uploaded documents of valid successful bidders will be verified with the original before signing the agreement. The valid successful bidder has to provide the originals to the concerned authority on receipt of such letter, which will be sent through registered post / EMAIL.
11. Standard Bidding Documents (SBD) is not to be uploaded by the bidder. The bidder has to only agree / disagree on the conditions in the SBD. The bidders, who disagree on the conditions of SBD, can not participate in the tender.
12. Technical bids will be opened on-line on the day & time as specified in the above table, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
13. ~~Bids once submitted online can not be resubmitted or withdrawn.~~
14. Conditional bids and the bids not meeting the qualifying criteria on the date of receipt of bids shall be summarily rejected.
15. A Pre-bid meeting will be held on at PM at the office of Superintending Engineer, Construction Circle , PWD B&R, Chandigarh to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "Instructions to Bidder" bidding document.
