Subject: Issuance of NOC for approval of the passage on Chandigarh-Morinda Road on Other District Road (Old NH-95) for proposed access to proposed Retail Outlet of Hindustan Petroleum Corporation Limited at City Morinda, Tehsil Morinda, Distt. Rupnagar (Pb.) at KM 12.390 (LHS).


Hindustan Petroleum Corporation Limited i.e. the applicant has submitted a proposal to this office on above captioned subject. The applicant has sought relaxation from the Guidelines/Norms for Access, Location & Layout of Roadside Fuel/ Service Station along SHs/MDRs/ODRs/Link Roads as listed in guidelines for issuance of NOC issued by Department of Public Works (B&R-3 Br.) vide letter No. 12/23/2019-3BR3/1402253 dated, Chandigarh: 24.01.2019. Sub Divisional Engineer, Central Works Sub Division, Chandigarh submitted his inspection report mentioning that a railway crossing exists at a distance of 982 mtrs. from the site of this proposed retail outlet. Whereas norms contained in IRC: 12-2016 it has been mentioned that "Distance from Check Barrier/Toll Plaza/ Railway Level Crossing should be minimum 1000 Mtrs. So the applicant vide their application No. CRO/RET/GY Dated: 13.08.2020 requested to give relaxation the above guidelines/norms issued by Department of Public Works (B&R-3 Br.) and accordingly Public Comments (if any) are invited.

As per Department of Public Works (B&R-3 Br.) vide letter No. 12/23/2019-3BR3/1402253 dated, Chandigarh: 24.01.2019 Executive Engineer will make available the relaxation proposal of Oil Company for public comments and the comments will be invited within 45 days from the day of uploading.
