On the matter cited as subject, Show Cause Notices were served to your agency vide letters under reference that why not the amount of Rs. 18,67,889/- & 16,11,158/- be recovered from you and why your agency may not be blacklisted from PHSC for any new work/project. The replies submitted by you have been examined and found to be totally unsatisfactory and unacceptable as dissimilarity between newly installed & old installed & old wood work can be easily adjudged from its features, design, pattern, aluminum fittings used etc etc and cannot get deteriorate in such a small span of time. Therefore, it is wrong to say by you that the physical verification has been conducted approximately after 2 years, 4 months of the completion of the works and it is quite obvious that the new work done cannot remain same after such a long time. It has therefore found that you were well conversant with the actual works done at site and about record entries made in the measurement books/bills. But you never pointed out about these discrepancies and willfully accepted the payments of works which were actually not done at site. By doing this you have involved yourself in fraudulent practice to get undue financial benefits of approximate of Rs. 18,67,889/- & Rs.16,11,158/- from PHSC.

Keeping, in view the above, your agency is hereby blacklisted & debarred from PHSC forever to participate any type of activity an amount of

Rs. 18,67,889/- & 16,11,158/- is recoverable from your agency. You are directed to deposit said amounts with PHSC immediately.
