**Subject: *Violation of clause 3.3 and 3.6 of Instructions of Enlistment 2016 by M/s Inder Mohan contractor enlisted in category of Building Works as class-I contractor.***

With reference to above mentioned subject, it is intimated that during the scrutiny of application for revalidation of M/s IHR Associates, it was noticed that you are registered in PWD (B&R) as a Sole Proprietor in M/s Inder Mohan Singh contractor for class-I in category of Building works and as a partner with 40% partnership holdings in M/s IHR Associates. You have violated clause 3.3 and 3.6 of Instructions of Enlistment 2016. Show cause notices were issued to explain your position on this matter vide PRBDB office no. 3318-20 dated 18.07.2022 and consequently reminder was also issued vide memo no. PRBDB/3828 dated 10.08.2022. You were also requested to appear in the meeting of enlistment authority via VC on 16.08.2022. The reply to the show cause notices was not received. As you didn't appear in the VC meeting before the Enlistment Authority, therefore, in your absence, the enlistment authority has decided to cancel the enlistment certificate issued vide this office enlistment no. PRBDB/Class-I/0602 dated 16.03.2021 and remove M/s Inder Mohan Singh from the approved list of contractors as per clause 23.1(iii) (i) for a period of 3 years i.e upto 16.08.2025.


