The enlistments as Class-I contractor in the categories of Road Works vide Enlistment No. PRBDB/Class-I/0462, dated 27/05/2020, was issued in respect of your agency i.e M/s A.K. Builders. The validity of the above said enlistment was for a period of two years i.e. from 01.04.2020 to 31.03.2022. During this enlistment period the work mentioned as subject was allotted to your agency. Now SE, Chandigarh vide its letter no. 4083 dated 09/12/2022 has intimated to this office regarding bad quality of work executed by your agency in the following work:

## (4) Teur Jakkarmajra Link Road

Superintending Engineer, Construction Circle, Chandigarh has recommended to demote your agency under clause 23(1) of the enlistment rules.

In light of above, a meeting of the Enlistment Authority was called on 15/12/2022. In the meeting it was observed that the default of your agency falls under 23.1(i)(a) of the enlistment policy instructions of the department. As such your agency needs to be demoted. But as per records your agency is presently not enlisted with Punjab PWD (B&R). Therefore, it was decided that whenever your agency applies for enlistment, your agency will be enlisted in a lower category than the category your agency is eligible for a period of first 6 months.
