Whereas, in exercise of the powers conferred by sub-section (1) of section 11 of *The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013*, (hereinafter referred to as "the Act"), the Government of Punjab has notified, vide notification no. PWD-BR 307/25/2020-1BR3/206603/2021/1-4 dated 05.07.2021, that the land specified in the Schedule below is likely to be required for public purpose, namely, "for construction of Rajpura-Bathinda Double Line project of Ambala Division of Northern Railway". The substance of the said notification for the additional land was published in two daily newspapers namely "The Tribune" in English language and "Ajit" in Punjabi language on 18.08.2021;

and whereas, the Social Impact Assessment Study for the project was carried out by the State Institute of Rural Development and P**a**nchayati Raj, Punjab, under section 4 of the Act and the same was reviewed by the expert group, the recommendations of which have been accepted by the Government of Punjab. As per the Social Impact Assessment report, no person is being displaced as a result of acquisition of the scheduled land. Therefore, in this connection, the Rehabilitation and Resettlement Scheme is not required ;

and whereas, the Government of Punjab is satisfied after considering the reports submitted by the Sub-Divisonal Magistrate, Bathinda in expercise of the powers conferred by sub-section (2) of section 15 of the Act, that the said land is needed to be required for public purpose;

and therefore, in exercise of the power conferred by sub-section (1) of section 19 of the Act, the government of Punjab hereby declares that the land specified in the Schedule below is required for the said public purpose ;

and whereas, claims to the compensation, if any, may be made by the persons interested within 30 (thirty) days after the date of publication of this notification, in person or by agent or advocate, to the office of the Sub-Divisional Magistrate, Bathinda as provided under section 21 of the Act. Such claims shall clearly state the nature of respective interests of the said persons in the land and the amount and particulars of their claims to compensation for such interests, the claims to Rehabilitation and Resettlement along with objections, if any, to the plans for the land.

Plans for the land may be inspected in the office of Land Acquisition Collector-cum-Sub- Divisional Magistrate, Bathinda during office hours.
