The enlistment as Class-I contractor in the category of Road Works, vide enlistment no. PRBDB/Class-1/687 dated 01.10.2021 was issued in respect of your agency. The validity of the above said enlistment was for a period of two years i.e from 03.12.2020 to 02.12.2022. In pursuant to the recommendation of Superintending Engineer, Construction Circle, Sangrur, it has been observed by the Enlistment Authority in its meeting dated 01/11/2023 that your agency has failed to take up the work after allotment on more than one occasion.
