Subject: Regarding disciplinary action against the agency M/s NKC Constructions Pvt. Limited on the basis of following work:-

Stg. of 32.200 Km section of Phagwara Hoshiarpur road (km 0 to 32.200) on NH 344B in the state of Punjab on EPC Mode.

The enlistment as Class-I contractor in the category of Road Works, vide Enlistment No. PRBDB/Class-I/790, dated 21.07.2022 was issued in respect of your agency. The validity of the above said enlistment was for a period of two years i.e from 10.08.2022 to 09.08.2024.

Vide reference No. 1 and 2, this office was requested to take disciplinary action against your agency in the said matter. In accordance with Clause 23.1 of Instructions of Enlistment, 2016, your agency was given a chance to explain your position in the matter through Show Cause notice and consequently through VC on 08/02/2024 at 10:45 AM. Written reply to Show Cause Notice submitted by your agency alongwith points highlighted by your representative in the meeting of Enlistment authority were taken on record and discussed in the meeting of Enlistment Authority on dated 08.02.2024 at 11:00 AM.

During the meeting of Enlistment Authority, it has been observed by the Enlistment authority that your agency has got adverse report related to adverse performance in the work cited as subject which falls under Clause 23.1 (i) (a) of Instructions of Enlistment, 2016 " **Demotion to a lower class** The contractor shall be liable to demotion to a lower class, by the Enlistment Authority, if he: (a) **fails to execute a contract or executes it unsatisfactorily or is proved to be responsible for constructional defects/ deficiencies.**"

In light of above, the Enlistment Authority has decided to cancel the enlistment certificate issued to your agency by the office of PRBDB vide Enlistment No. PRBDB/Class-I/790, dated 21.07.2022 with immediate effect and demote your agency as per clause 23.1(i)(a) of Instructions of enlistment - 2016 for a period of 3 months i.e upto 08.05.2024. The enlistment authority has further decided to issue revised enlistment certificate to your agency.
