In continuation of this office memo no. PRBDB/268-272 dated 05/04/2024.

Your firm was enlisted in category of Civil - Road Works in Class-I (up to Rs. 10.00 crore) vide enlistment no. PRBDB/Class-I/0355 dated 30/08/2019, valid upto 31.07.2021.

Provisional enlistment was issued valid upto 31/07/2023, in response to Interim Orders passed in CWP 9404 of 2023 on dated 03-05-2023 by Hon'ble Punjab and Haryana High Court. In view of the application uploaded by your agency for revalidation as Class-1 contractor in category of Road Works on 04/07/2023, the meeting of enlistment authority was held on 11.07.2023 through VC. During the meeting, it was decided to provisionally extend the revalidation of your enlistment from 31.07.2023 to 13.09.2023, the next date of hearing in CWP-9404 of 2023.

The next date of hearing in the case was then fixed on 14.11.2023. Therefore, based upon the orders dated 03.05.2023 of Hon'ble Punjab and Haryana High Court in CWP 9404 of 2023, enlistment authority decided to further extend the provisional enlistment of the agency upto next date of hearing in CWP 9404 of 2023 i.e 14.11.2023, which was further extended upto 02.04.2024 and then upto 08.05.2024 as per orders of Hon'ble Punjab and Haryana High Court.

Now, Hon'ble Punjab and Haryana High Court vide decision dated 08/05/2024 has ordered as below:-

"The present writ petitions are disposed of at this stage without commenting on the merits of the case and directing the respondents to allow the petitioner to participate in the tenders that may be floated till such time a decision is taken with respect to renewal/revalidation of the enlistment of the petitioner under the Instructions for Enlistment of Contractors in Public Works Department, 2016.

In the meanwhile, the order dated 03.05.2023 shall continue to enure in favour of the petitioner till decision on the pending application for renewal/revalidation and for a period of 15 days thereafter to enable the petitioner to avail his alternative remedies.

The petitions are disposed of accordingly."
