No. 12/68/13-3B&R3/955236/1 Whereas the Governor of Punjab deems it necessary to amend the Notification dated the 8<sup>th</sup> July 2004 issued vide No. S.O. 11/P.A. 13/1998/Ss. 2, 3 and 4/2004 by the Government of Punjab, Department of Public Works (Buildings & Roads Branch) and whereas, in view of proviso contained in para 20 of the Notification dated 5<sup>th</sup> September 2013 issued vide No. S.O. 72/P.A. 13/1998/Ss. 2, 3 and 4/2013 by the Government of Punjab, Department of Public Works (Buildings & Roads Branch) that the Notification dated 8<sup>th</sup> July, 2004 ibid would continue to be applicable to Concession Agreements already in vogue under the Notification dated 8<sup>th</sup> July, 2004 ibid:

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 3 of the Punjab Mechanical Vehicles (Bridges and Roads Tolls) Act, 1998 (Punjab Act No. 13 of 1998), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following amendment in SCHEDULE-I appended with the Notification dated 8<sup>th</sup> July, 2004 of Department of Public Works (Buildings and Roads Branch) issued vide No. S.O. 11/P.A. 13/1998/Ss. 2, 3 and 4/2004:

**AMENDMENT**

In the said Schedule

- (1) the expression "and" shall be substituted with the mark ";" at the end of the item (e).
- (2) the mark "." shall be substituted with the mark ";" at the end of the item (f).
- (3) The following items (g) and (h) shall be inserted after item (f), namely:-

(g) the vehicle of an Accredited Media Person or a Media Person having yellow Identity Card issued by the Punjab Government, if he or she produces such Accreditation Certificate and/or yellow Identity Card; and

(h) the vehicle of Freedom Fighter, if he or she produces his or her identity card and certificate issued by the Punjab Government.

**This Notification shall come into force with immediate effect and shall also be applicable for the Concession Agreements already under implementation.**
