

These powers will be utilized for approved works. These will be further subject to following conditions:-

- (1) These power shall be subject to availability of Administrative Approval and Administrative Approval must be endorsed by concerned Chief Engineer. In case direct Administrative Approval has been issued to Superintending Engineer/ Executive Engineer by District Administration or some other agency, a copy of Administrative Approval will be sent to concerned Chief Engineer before taking any action.
- (2) There is no change in scope of work than taken in Administrative Approval.
